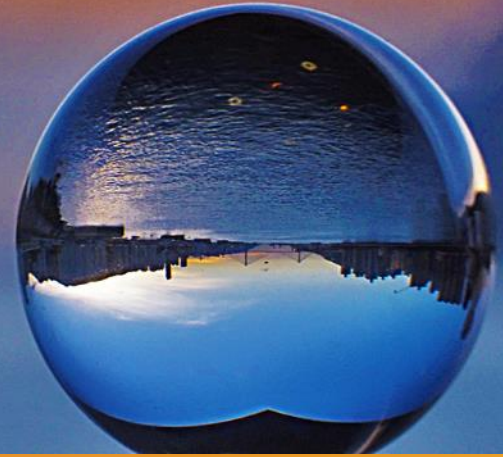

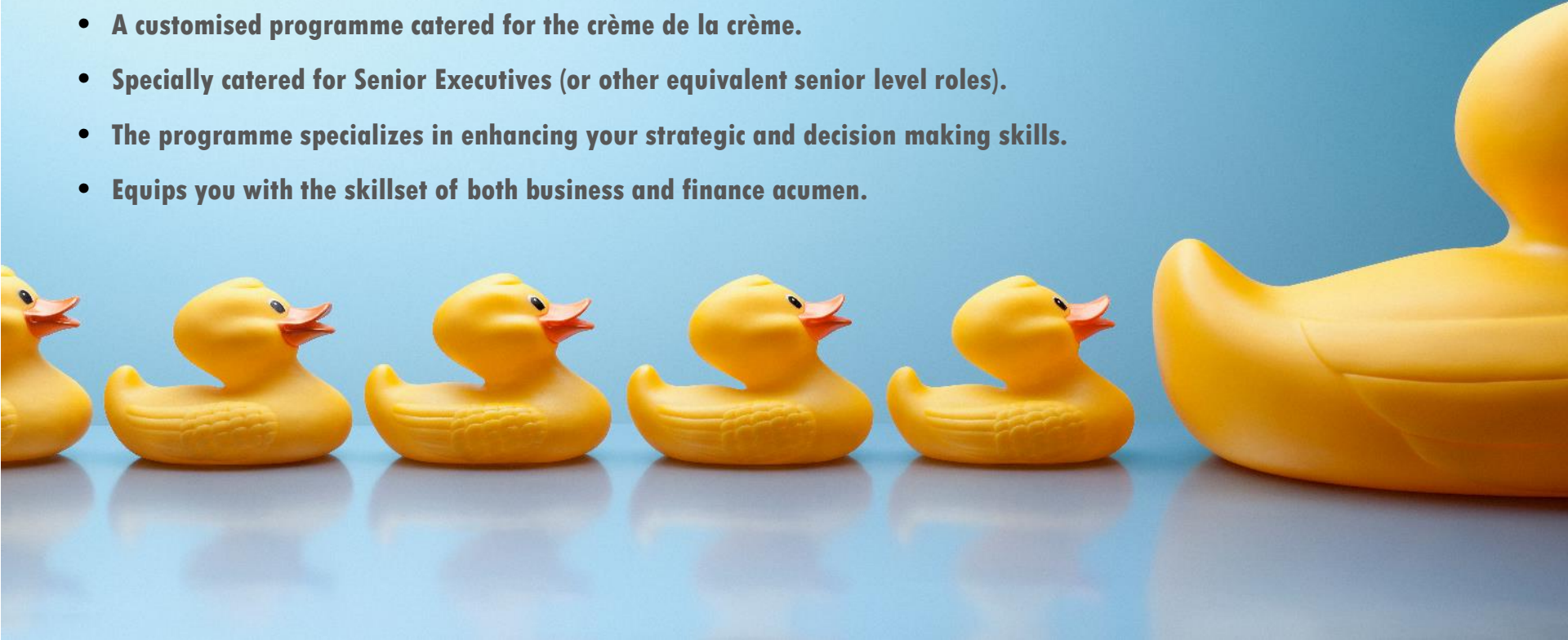

- **Must sit for MCS and SCS, and complete CGMA membership application within 12 months upon registration.**



# How does this work?

## ACMA/FCMA/CGMA

- **Must be an active member registered in Vietnam.**
- **Eligible to refer candidates (who can be your colleagues, staff and business partners) to be admitted under this programme.**
- **The referred candidates can enjoy a special discount on tuition fees if they sign up for classes with FTMS Vietnam upon successful application.**

# Application process

1. Candidates complete the registration by submitting the completed registration form, detailed CV, a copy of passport and a copy of highest educational qualification to the designated personnel from CIMA or FTMS.
2. Candidates receive acceptance notice from CIMA.
3. Candidates sit for MCS and file application for CGMA membership upon passing MCS.
4. Candidates sit for SCS.
5. CGMA membership awarded upon passing the SCS and successful membership application.



# Required documents for application

- Detailed CV
- Copy of valid passport
- Completed application form
- Copy of highest educational qualification





# How much would it cost?

- **£1,500**
- Includes CIMA registration fee, exam fee for MCS and SCS (1 sitting each) and exemption fee.
- Local study support may differ in each market.
